The "Level 6 NVQ Diploma in Occupational Health and Safety Practice" is a qualification designed for individuals involved in occupational health and safety roles. NVQ stands for National Vocational Qualification, and Level 6 indicates a higher level of complexity and specialization. This diploma is likely to cover advanced aspects of occupational health and safety practices, and individuals completing this qualification are expected to have a deep understanding of the subject matter along with the practical skills required for the role.

### Learning Outcomes

- Risk Assessment: Conduct and apply comprehensive risk assessments.
- Legislation Compliance: Ensure adherence to occupational health and safety legislation.
- Incident Investigation: Proficiently investigate and report occupational incidents.
- Safety Policies: Develop, implement, and monitor effective safety policies.
- Communication: Communicate health and safety information clearly to diverse stakeholders.
- Emergency Planning: Develop and implement emergency response plans.
- Continuous Improvement: Implement strategies for continuous improvement in health and safety.
- Leadership: Exhibit leadership in promoting and maintaining a safe working environment.

- Develop and implement the health and safety policy.
- Develop and implement effective communication systems for health and safety information.
- Develop and maintain individual and organisational competence in health and safety matters.
- Identify, assess and control health and safety risks.
- Develop and implement proactive monitoring systems for health and safety.
- Develop and implement reactive monitoring systems for health and safety.
- Develop and implement health and safety emergency response systems and procedures.
- Develop and implement health and safety review systems.
- Maintain knowledge of improvements to influence health and safety practice.

### Entry Criteria

Since there are no formal entry requirements for this qualification, Centres will carry out an Initial assessment of candidate skills and knowledge to identify any gaps and help plan the Assessment. This qualification is approved for candidates aged 19+
